

Important Notices for SAT Test-Takers in KSA

□ In regard to the prevention of COVID-19 infections, KSA must follow the Korean government's regulations, so **parents and guardians are not allowed to enter the test site** of the day of the test. Followings are the steps you have to cooperate to keep all test-takers, staff, and campus safe.

- All test-takers **must wear KF 94 face mask all the time.**
(However, please briefly take off the mask during check-in to verify the required identification.)
- All test-takers will have their body temperature checked before entering the test center and during break time.
 - So, **please arrive at the test site by 7:30 AM** since it takes some time to complete the temperature check.
 - If a test-taker have COVID-19 symptoms such as fever or respiratory issues, taking test may not be granted.
 - **When checking the temperature before check-in, a test-taker's body temperature is over 37.5°C, taking test is prohibited.**
 - **If a test-taker is COVID-19 positive or under the control by the government such as close contacted, taking test is prohibited.**
(It is a breach of the law.)
 - If COVID-19 symptoms occur during testing, please notify your test proctor immediately.
- All test-takers should sanitize their hand when entering the test site. Please wash your hands thoroughly when using bathroom.
- Talking to each other is prohibited. Please carefully follow the social distancing guidelines.
- All test-takers should sanitize their desk twice with the wipe provided: 1) When you take a seat, 2) After you are dismissed.

Important Notices for SAT Test-Takers in KSA

Test Day Requirements

- Printed **admission ticket**
- Government-issued **Photo ID** from the country where they're testing (such as Passport, Korean ID Card, Driver's License Card)
 - ✓ It is extremely important that all the information on your admission ticket and photo ID should be matched. If not, the check-in will not be allowed.
 - ✓ If your passport or photo ID is expired, it is not acceptable.
 - ✓ Student Card is not acceptable.
- **COVID-19 Safety Self-Screening Questionnaire**
- Two **No. 2 pencils (HB pencils)** with erasers
- An acceptable **calculator**

- Extra masks
 - ✓ Please be noted that if you do not bring any of test day requirements, taking the SAT test is not possible. It is your responsibility to get yourself ready for the SAT test.

What you can bring to the test center

- A simple, non-digital watch
- Full water bottle and snacks
 - > You may take water and snacks during break time outside the building, not at the testing room.
- Extra batteries and backup calculator if available
